About the pilot

The Queensland Community Pharmacy
Pilots allow eligible consumers to access
a broader range of services from a
participating pharmacy. In addition to their
existing qualifications and registration
with the Pharmacy Board of Australia,
participating pharmacists have completed
additional clinical training to provide these
new services. This training includes the
completion of two university-level courses
and clinical practice.

Are you eligible?

Our staff will help determine if you are eligible to access services as part of a Queensland Community Pharmacy Pilot, ensuring that you receive the appropriate health care for your needs. If you are not eligible for a pilot service, your pharmacist may refer you to other healthcare providers, such as a GP or the Emergency Department.

What will these services cost you?

Your consultation and any additional costs are:

- **not** eligible for a rebate under Medicare
- **not** subsidised by the Pharmaceutical Benefits Scheme (PBS).

Consultation fees range between \$18.85-\$68.10 depending on the service provided.

Consumers must pay all costs associated with the service. This includes any additional costs associated with the service such as items used during the consultation and as part of ongoing care (e.g. medications, pathology tests, bandages).

Check with your pharmacist about the costs associated with the service before you agree to receive care.
