New Medical Board appointed

The Newman Government has appointed a new 12 member Queensland Medical Board to ensure a more effective and accountable health complaints process.

Last year members of the former board resigned or were removed following reports from the Crime and Misconduct Commission, a former Crown prosecutor and a review panel comprising a legal practitioner, a medical practitioner and an individual with regulatory experience which raised concerns about the manner in which health complaints were being dealt with.

Health Minister Lawrence Springborg said that the reports detailed the board's failure to properly deal with complaints.

"As a direct result of those reports we have appointed a board which includes greater community representation in addition to medical practitioners," Mr Springborg said.

"In keeping with a recommendation of the Chesterman Review / CMC Report of the Queensland Board of the Medical Board of Australia, we have appointed a chairman who is not a medical practitioner.

"As a direct result of the former Labor Government's mismanagement, the health complaints system spiralled into disarray with one case alone taking more than six years to finalise and police called in to investigate half a dozen doctors.

"The new board will be chaired by Associate Professor Susan Young, with support from Dr Mark Waters as deputy chair.

"The recruitment process for the new board has been extensive and I believe we have chosen people who will provide leadership and experience from both a community and medical perspective.

"Associate Professor Young is highly qualified and will bring a wealth of experience in the health and education fields.

"She has a Doctorate of Education and holds a Master of Education, majoring in Leadership and Management.

"She is also a highly experienced nurse and midwife and has fulfilled executive appointments in hospital administration and rural health. She served as the chairperson of the Queensland Nursing Council for six years and during this time, participated in national and international forums on professional regulation."

Mr Springborg said Associate Professor Young's skills and experience in serving on boards and committees would provide direction and guidance to the new Queensland Medical Board.

"Queenslanders deserve a trusted and reliable health complaints system which ensures issues are referred, handled and resolved in a professional and timely manner. I am confident the new board will achieve this going forward," he said.

Reliable supply of influenza vaccination for children under 5 years old

The AMA urges you to ensure that there are adequate supplies of influenza vaccinations appropriate for children under 5 years of age available in Queensland throughout the flu season.

I understand that the Commonwealth is currently renegotiating the Influenza Deeds to the National Partnership Agreement on Essential Vaccines. This provides you with an opportunity to negotiate an appropriate proportion of brands of flu vaccines for the population of Queensland.

Since the bioCSL brand *Fluvax* was delisted in late 2010 for use in children under 5 years old, our members have reported shortages of the brand appropriate for use in young children towards the end of each flu season.

I note that clause 5 of the Influenza Deeds requires states/territories to forecast in February and September its influenza vaccine requirements. This information should be useful in determining the needs of Queensland and prevent inadequate supply compromising the appropriate immunisation of young children.

I would be happy to discuss this issue with you in more detail and to work with you to ensure there is adequate supply of influenza vaccine for children under 5 years old.

Dear Minister

It has been brought to our attention that the Australian Health Workforce Ministerial Council (AHWMC) recently rejected recommendations from the Medical Board of Australia to recognise Genetic Pathology and Clinical Pathology as specialties for registration purposes.

We would like to express our concern with this decision and the accompanying explanation which was provided in Minister O'Byrne's letter to the Chair of the Medical Board of Australia on 8 August 2013. Two matters were cited for the rejection:

1. Workforce implications that need to be resolved before the pathology (and presumably other) specialities can be considered for approval; and
2. A current process for reviewing and approving a "specialities criteria" for specialist registration under the National Registration and Accreditation Scheme.

Australia has a long standing, rigorous and internationally respected criteria and process for the recognition of medical specialties by the Australian Medical Council (AMC).

We note that AHWMC has not identified the "workforce implications" or explained how they are material to the approval of new medical specialties. We ask that the medical profession be provided with information about the "workforce implications" that are germane to the recognition of medical specialties.

With respect to the second reason for rejection, we understand that this work relates to the non-medical health professions, yet Minister O'Byrne's letter advises that another application for approval would be considered on its merits after the review. If AHWMC intends to review and revise the criteria for medical specialties, we insist that there be formal consultation with the AMC and the medical profession. If this is not the case, the review is not sufficient ground on which to reject the Medical Board's recommendation and the AHWMC should reconsider its decision now, and not after the review.

The AMA notes that AHWMC has not made any public announcements with respect to the two issues provided as reasons for not approving the recommendations of the Medical Board.

This lack of transparency only serves to cast doubt on the AHWMC stewardship of the health workforce and health workforce policy.




My apologies for the late response

I have added comments and suggestion around two primary concerns – we need to develop strong business models for the adoption of telehealth as a cost saver or to generate income through delivering services efficiently. The private sector has been able to demonstrate this and then support the uptake of the technology. Without the economic driver the easy argument of ‘we’re not funded for this’ will rule even if there is the technology readily available (as it is now with the systems in hospitals chronically underutilised).

The second concern is the intent to develop one centralised service for non-acute. The capacity to utilise telehealth for acute management and retrieval is in place now with the level of usage variable for a number of reasons but one of them is the lack of relationship between the services. This results in the services being used only as a final option until the clinicians are comfortable with the services. For non-urgent services the existing technology could be used with a connection to the regional hospital A &E and specialists the rural hospitals refer to regularly. Other technology could be used for a grand round with high risk patients referred for review early and possible transfer to the regional centre or supported local management. The potential of a regional model needs to be considered prior to the development of a centralised service.

The potential for telehealth to increase access to services for patients (especially those in remote and rural communities) and the potential to increase service efficiency need to drive the service models developed.

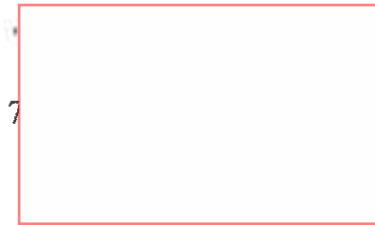

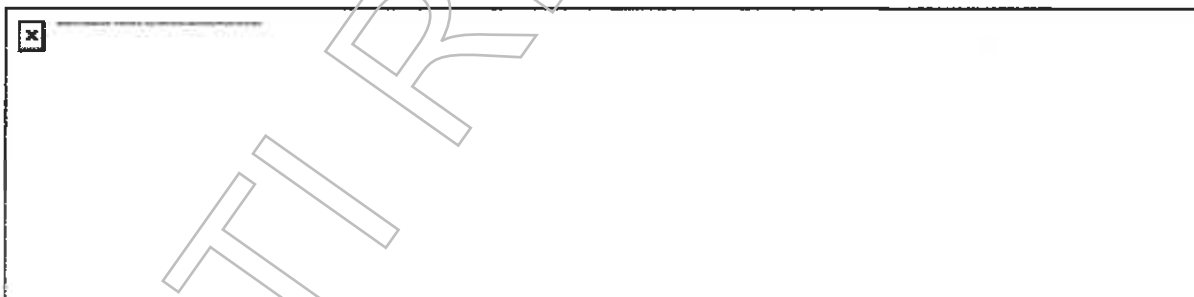

A message to all VMOs

During the past six months I have been negotiating with Qld Health regarding a suitable draft of a proposed Contract of employment for VMOs. I granted Qld Health a six month extension of our current agreement so that the expiry date is now 30th June 2014. The full year fuel allowance will be payable in February 2014.

A proposed employee contract is now available for your consideration. I wish to explain why I consider this draft deserves your serious review.

1. CURRENT ARRANGEMENT

By our own choice VMO employment is governed by a non certified agreement. We maintain our independence but have no protection of an award or reference to Qld Industrial Relations Commission (QIRC). Governments in the past have ignored expiry dates of our agreements and I have resorted to media support and pending elections to fight off two directives and agreement renewal delays of 2-1/2 and even 4 years. Individual contracts will overcome these issues as your entitlements will be reviewed annually.

2. BENEFITS IN DRAFT OF PROPOSED CONTRACT

The current draft is not a simple translation of your present entitlements, although important entitlements have been preserved.

Further benefits include:

a. Payrise of 2.2% to base salary.

This is not written in the draft but is supported by the Director General and Health Minister. The policy requires ratification by a government committee due to meet in December 2013.

b. Professional Development Leave

The draft gives ability to draw down on accumulated hours (4 weeks per year to 4 years), so that leave taken does not have to correspond with your sessional time (core hours) as at present. You therefore should be able to utilise the benefits of this leave unlike the present arrangement.

c. Fuel Allowance.

This will be a permanent feature of your entitlement.

d. Payment for all professional services outside of core hours.

This will be available in tier 2. No AVAC forms will be required.

e. Professional development assistance (PDA).

This will be available to all VMOs irrespective of core hours commitment.

f. Fee for service.

This option at DVA rate is maintained for clinical services outside of core hours for country VMOs. I have received support for this to be extended to Townsville Hospital. The details are not yet available and do not appear in the current draft but resolution of this issue is a caveat for my support for the present draft.

g. Private practice - schedule 3.

This requires a specific signed agreement if the HHS desires it and the VMO agrees to participate. Adequate indemnity and best practice issues for distribution of funds to clinical divisions have been agreed and will be available in writing before commencement of contract employment on 1/7/2014.

3. PROVIDING CLARIFICATION ON INFORMATION CURRENTLY IN THE PUBLIC DOMAIN

a. A contract will significantly alter your current entitlements, remuneration or private practice income.

It is the Government's present intention to provide the same rates of pay and similar entitlements. Base rate to be increased by 2.2%. Loaded rate fixed and unchanged at 48%. PDA extended and fixed and fuel allowance fixed. You will need to negotiate your own tier 2 payment.

b. Doctors in similar positions will be paid differently.

There is no guarantee in the document of any specific level of pay, with rates of pay to be negotiated. The Department's position is that there will be a fixed base rate, with an increase of 2.2% on current rates, but that has not yet been approved as government policy. There may be variation between doctors in Tier 2, but it would seem a foolish HHS if this was attempted in the same department unless individuals agreed to vary their out of core hour commitment.

c. Superannuation can be affected.

Superannuation will be payable on the loaded rate as at present.

d. HHS chief executive can alter the terms of the contract.

The contract can only be changed by the parties to the contract by agreement. However, the Director-General can issue or change current employment related directives, which can unilaterally change entitlements. There are no restrictions on the Director-General consulting or even advising VMOs of the changes to directives.

e. Unfair dismissals and Industrial disputes - QIRC.

As explained, the VMOs are employed individually and QIRC has no jurisdiction now.

f. Consultation closes on November 29, 2013.

I have agreed to meet as many VMOs as possible during December. Such meetings are to be arranged by Queensland Health.

g. Negotiation time frames are unreasonable.

I agreed to extend the current agreement by 6 months to 30/6/14 to allow the contract negotiation process to occur.

h. Forced hasty decision.

You should take all the time you wish during any negotiations. More than one session may be required and is expected. Take someone with you if you wish. While you are entitled to attempt to negotiate changes to the terms of the contract, it is unlikely any changes will be agreed.

4. AREAS OF CONCERN

The Government refuses to recognise joint ownership of any intellectual property, such as copyright in research or papers, created in the course of employment.

The Government insists on having a contractual right to suspend without pay and a right to deduct pay if a VMO does not give sufficient notice of their intention to leave employment.

The Government intends to set employment conditions based on directives, which are easily changed without notice. Although the present agreement is

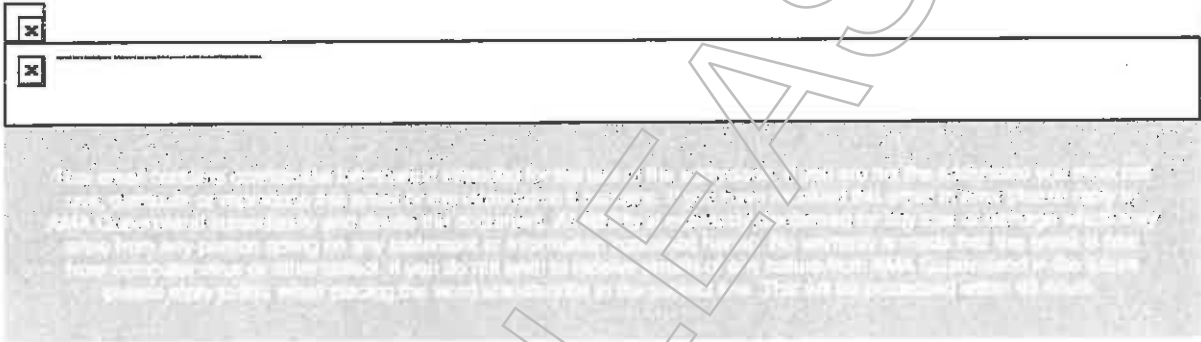
not a certified agreement, it has always been applied as setting guaranteed minimum terms for VMOs. Without an agreement of that nature underpinning the employment of VMOs, there can be uncertainty.

While it would be preferable to have individual contracts, with the VMO agreement as the base set of terms for all, I ask you to consider these points as you read the draft now available in relation to your own circumstances.

There have been multiple drafts before the current version. I hope any transition to contracts will allow the input of VMOs in our hospitals to increase. This is our chance to offer some real leadership.

"Alcohol attributable hospitalisations are on the increase – there were more than 50,000 of them in NSW in 2011-12.

"Emergency department attendances for acute alcohol problems are steady at around 9,000 a year.

"Alcohol abuse is adding a significant burden to the health system in NSW both in terms of economics and resulting in avoidable hospital presentations.

"The Audit Office estimates the total societal costs of alcohol abuse to NSW at \$3.87 billion or \$1,565 for every household in the state," A/Prof Owler said.

"I welcome the Auditor-General's renewed call for the State Government to look at supply side initiatives to combat alcohol abuse.

"NSW is facing a massive cost that could be avoided if the Foundation for Alcohol Research and Education's 10-point plan to combat alcohol abuse was adopted.

"This involves limiting availability of potentially alcoholic drinks late at night, reducing trading hours for licensed premises and mandatory lockouts in the early morning.

"This simple suite of measures has been proven to significantly reduce the level of alcohol-related assault in Newcastle and this report is a reminder the NSW Government needs to seriously look at this to combat the state's \$3.87 billion alcohol problem," A/Prof Owler said.

"Rightfully, many are calling for people to exercise personal responsibility.

"However, when one of the primary effects of alcohol on a person is to reduce their inhibitions, we should be looking at ensuring everyone involved in getting an alcoholic beverage to someone is acting responsibly also.

"Evidence shows the best way to combat alcohol abuse is to ensure people are responsible as well as the venues and regulations surrounding drinking," A/Prof Owler said.

"Additionally, we cannot take the idea of alcohol abusing user pays too far, we cannot make cost a factor that stops people seeking medical care or support for alcohol issues," A/Prof Owler said.
